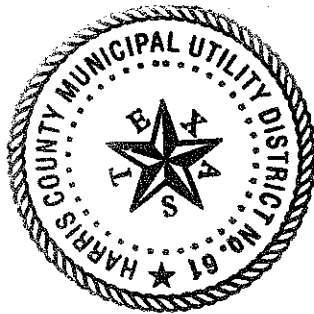
The meeting will be held on Tuesday, April 26, 2011, at 6:30 p.m.

The subject of the meeting will be as follows:


1. Consider comments from members of the public;
 2. Review and consider approval of minutes of the March 22, 2011, Board of Director's meeting;
 3. Consider financial and investment reports, including invoices presented, and the taking of any actions required in connection therewith, including authorizing the payment of invoices presented;
 4. Consider report on the status of collection of taxes, the status of collection of delinquent tax accounts, the payment of invoices, and the taking of any actions required in connection therewith;
 5. Consider authorizing the District's Tax Assessor Collector to move the District's bank account from Frost Bank to Sterling Bank;
 6. Consider adoption of Resolution Authorizing Additional Penalty on Delinquent Taxes;
 7. a) Consider authorizing the design, advertisement for bids and/or award of construction contracts for construction of water, sanitary sewer and drainage facilities within the District, and the taking of any actions required in connection therewith, including:
 - (i) review bids and concur in award of contract for extension of District facilities to serve the StoneArch development; and
 - (ii) authorizing preparation of plans and specifications for rehabilitation of sanitary sewer system;b) Consider status of construction contracts and the approval of any change orders and/or acceptance of facilities for operation and maintenance purposes, and the taking of any actions required in connection therewith, including:
 - (i) contract with S.T.P. Services for electrical portion of detention pond fountains;c) Consider acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and the taking of any actions required in connection therewith;
 - d) Consider status of waterline relocation and installation of new valve relative to Harris County drainage modifications to Mason Road in connection with storm water flow into District;
 - e) Consider status of request to Harris County regarding Franz Road Office Park drainage issue; and
 - f) Consider status of installation of fire hydrant on District's waterline on west side of Mason Road by Weston MUD;
8. Consider approval of Resolution Authorizing Use of Surplus Funds and Interest Earned on Construction Funds relative to relocation of waterline and installation of new valve relative to Harris County drainage work on Mason Road;
9. Consider recommendations of board committee regarding issuance of bonds relative to sanitary sewer rehabilitation projects and developer reimbursement, and the taking of any actions required in connection therewith;
10. Consider requests for issuance of utility commitments and the taking of any actions required in connection therewith;

11. Consider report on regional sewage treatment plant, including compliance with wastewater discharge permit, and the taking of any actions required in connection therewith;
12. Consider report regarding the status of development of property within the District;
13. Consider report on District's water, sanitary sewer and storm sewer systems, including:
 - (i) Authorizing the repair and maintenance of District facilities;
 - (ii) Review of monthly service billings and collections;
 - (iii) Compliance with water well permit;
 - (iv) Appeals of District charges;
 - (v) Status of storage tank; and
 - (vi) Authorizing preparation of draft Consumer Confidence Report; and the taking of any actions required in connection therewith;
14. Consider report on investigation of District's water accountability, and the taking of any actions required in connection therewith;
15. Consider status of meter replacement throughout the District, and the taking of any actions required in connection therewith;
16. Consider status of storm sewer cleanout and debris removal from infrastructure within the District, and the taking of any actions required in connection therewith;
17. Consider surface water issues and the West Harris County Regional Water Authority, and the taking of any actions required in connection therewith;
18. Consider status of requests to Harris County Municipal Utility District No. 63 and West Harris County Municipal Utility District No. 5 for reimbursement for drainage easement, and the taking of any actions required in connection therewith;
19. Consider discussion regarding items to be placed in quarterly District newsletter; and
20. Consideration of matters for possible placement on future agendas.
